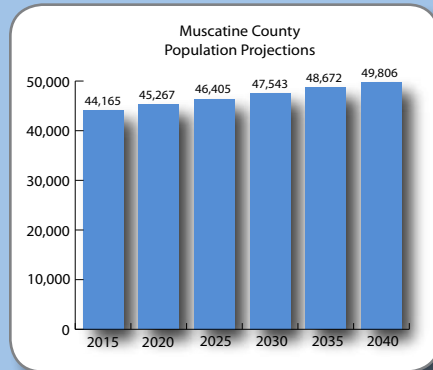


## Muscatine City of Business

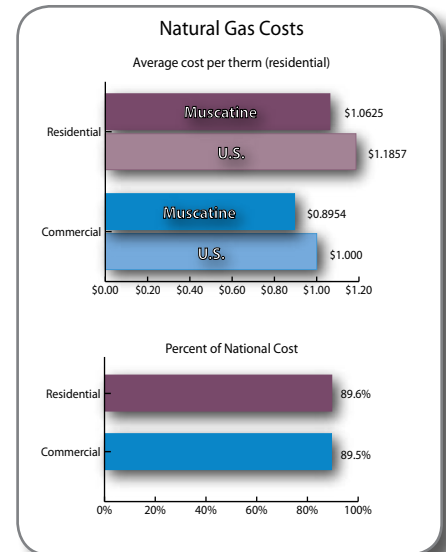

## Taxes

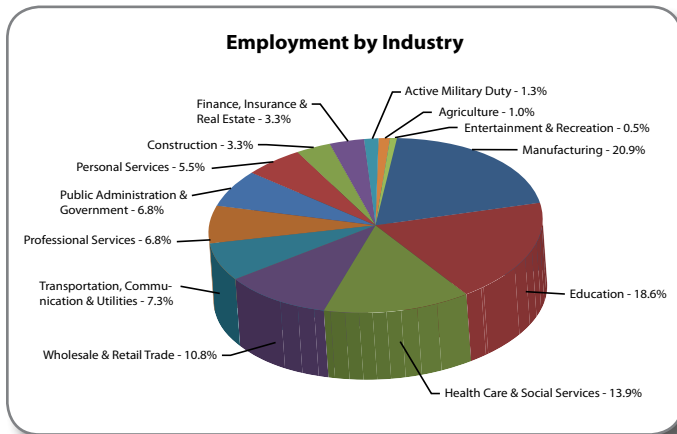
**State Corporate Income Tax:** Based solely on in-state sales.

**Federal Taxes Deductible:** Corporate = 50% • Individual = 100%

**State/Local Sales Tax:**

Current state sales tax is 5%, with two additional local option sales taxes of 1% each, bringing the total to 7%. All sales taxes exclude food, prescription drugs and medical devices.

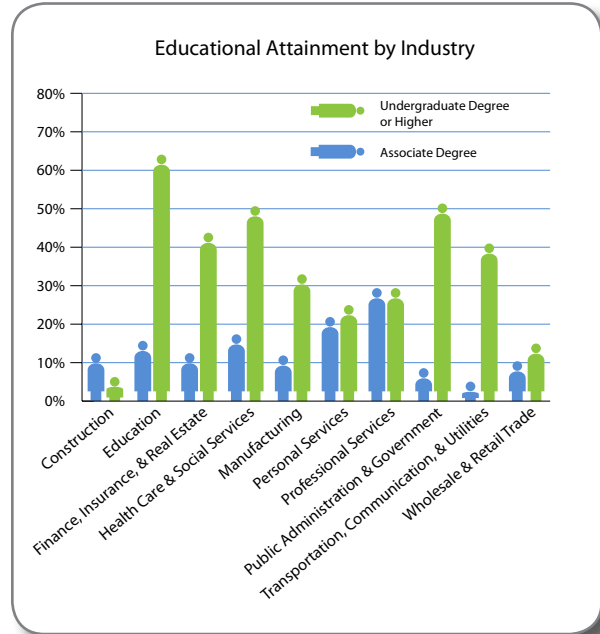
**Property Tax:** Manufacturing machinery, equipment, and computers are exempt from property tax.

## Educated Workforce

Muscatine has an educated workforce with nearly all major industries having **25%** or more of their employees with undergraduate degrees or higher. (Source: Iowa Workforce Development, Laborshed Analysis, August 2011). Out of the overall population aged 25 and over, **82.1%** are high school graduates and **20.1%** have a Bachelor's degree or higher. ### Higher Education

According to the Quad Cities Chamber of Commerce Study, *2010 Graduate Inventory*, there are nearly **50,000** students who received a degree within a 90-mile radius of the area.

Muscatine is home to **Muscatine Community College**. MCC provides a more affordable education, with easy transfer to most four-year colleges and universities, 100+ program options/majors, and one of the lowest tuitions in Iowa, MCC provides a quality education with smaller class sizes, highly qualified instructors and flexible course scheduling.

The **University of Iowa** is located in Iowa City, less than one hour away.

The Quad Cities **offers** two community colleges, a technical/trade college, one four-year college, two universities, a college of chiropractic, and a graduate center.



# QUALITY OF LIFE

Whether it's a stroll through its arboretum or a visit to the zoo garden, residents and visitors will find Muscatine offers a wide range of amenities and services that significantly enhance the area's quality of life. Muscatine's attractions dispel the myth that a small, Iowa community is incapable of rivaling the cultural and entertainment resources of much larger cities. Muscatine is a warehouse of historic buildings and structures; award-winning museums; exceptional parks, athletic facilities and outdoor sculpture sites; beautiful Mississippi River vistas; and other features that are continuing to expand in local, state, national and international significance.

## Attractions

**Mississippi River:** Enjoy magnificent views of the nation's preeminent waterway from the Mark Twain Overlook and our beautiful downtown riverfront or take advantage of the many recreational opportunities the Mississippi offers.



**Norbert F. Beckey Bridge:** A 1500-foot span connecting Iowa and Illinois, which becomes illuminated every night in an ever-changing rainbow of colors created by 43 LED fixtures.

**Historic Districts/Buildings:** Muscatine has two

national historic districts listed on the National Register of Historic Places (Downtown Commercial and West Hill) and two cultural and entertainment districts. In addition, there are several individual listings on the National Register.

### Arts/Culture/Museums

**Muscatine Art Center:** Accredited by the American Association of Museums and a Cultural Leadership Partner with the Iowa Arts Council, the Muscatine Art Center houses works by notable American artists Grant Wood, Georgia O'Keefe, and Allan Houser, as well as a collection of European masters. The Center's Great River Collection provides an especially interesting look at the "Father of Waters" from its source in Lake Itasca in Minnesota to New Orleans. The museum is located in the 1908 Musser Mansion and contemporary Stanley Gallery.

**Muscatine History and Industry Center:** Traces the economic history of Muscatine, from its beginnings as a trading post for Native Americans to becoming the home to a wide variety of national and international companies. The center includes an exhibit on the pearl button industry, which provided Muscatine's unofficial nickname, "Pearl of the Mississippi."



**Outdoor Sculptures/Fountains:** Enjoy the unique and beautiful Folded Circle Arc, Mississippi Harvest, Prayer of Peace, and Mississippi Mist.

**Performing Arts:** Muscatine offers an array of cultural facilities that rival those of larger metro areas, including the Muscatine Center for the Performing Arts, Muscatine Symphony Orchestra, Pearl City Players Theatrical Society, and Masquers Community Theatre.

## Recreation

**Parks:** With nearly 20 parks scattered throughout the city, there's no lack for recreational opportunities in Muscatine.

**Weed Park:** This 64-acre, multi-use park includes picnic areas, trails, shelters, sand volleyball, tennis courts, playground equipment, restrooms and open areas. This gem also features a restored log cabin, Weed Park Zoo Garden, Weed Park Rose Garden, and the Muscatine Aquatic Center (see below) and is the site of several Native American burial mounds.

**Kent Stein Park:** A 66-acre facility adjoining an 11-acre slough with 2 concession stands, 8 lighted baseball diamonds, 9 lighted softball diamonds, 9 lighted horseshoe courts, picnic areas, fishing, and restrooms.

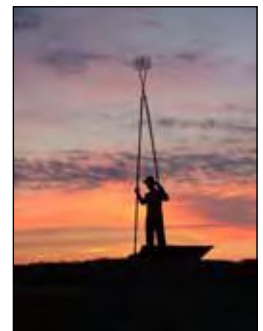
**Muscatine Soccer Complex:** The Muscatine Soccer Complex is a 41-acre, \$3.8 million soccer facility featuring 8 full-sized, state-of-the-art soccer fields. Two fields are internationally sized, lighted, and contain amended soils. The complex is fully equipped with concessions, media center, restrooms, and parking; and has been recognized by the National Turf Grass Managers Association as the "Best Soccer Facility."



**Muscatine Aquatic Center:** Located in Weed Park, the community's premier water activity center features 5 slides (2 drop slides, 1 family slide and 2 long slides), a zero-depth entry area and an interactive play structure with a kids' slide and spray area.

**Riverside Park:** Adjacent to downtown Muscatine on the Mississippi Riverfront, Riverside Park features Riverview Center, Pearl City Station (both available for event rental); Muscatine Boat Harbor & Marina; Mississippi (recreation) Trail; Mississippi Mist, an interactive splash fountain; and Eric Blome's "Mississippi Harvest," a monumental outdoor sculpture of a "clammer."

**Muscatine Municipal Golf Course:** Located one mile north of the City, this 18-hole facility offers a complete pro shop, concessions, cart rental, driving range, and private or group lessons.



**Wildcat Den State Park:** This 423-acre state park, located 10 miles east of Muscatine, features campgrounds, trails, 75-foot cliffs and rock formations. The 1848 Pine Creek Gristmill and Pine Mill Bridge are also located in the park.

**Trails:** A network of nearly 25 miles of paved and unpaved trails crisscross the community, including the 3.7-mile Mississippi Trail, which extends from Musser Park to Weed Park. Nearly half of this major trail includes the String of Pearls, a lighted section of trail that snakes along the Mississippi riverbank and recalls the city's heyday as the Pearl Button Capital of the World.
