MEMORANDUM

TO: Illinois Quad Cities Transportation Technical Committee Members and Other Communities in the Illinois Quad City Metropolitan Planning Area

RE: Request for Surface Transportation Block Grant (STBG) Program Candidate Projects for Evaluation Process in Illinois Quad Cities Metropolitan Planning Area

A Surface Transportation Block Grant (STBG) Program solicitation is being initiated to program the Illinois Quad Cities STBG targeted funds through 2025. In the Illinois Quad Cities, the estimated funds to be programmed are \$4,324,319. Annual funding targets for the Illinois Quad Cities are estimated at \$1,695,388 based on the federal Fixing America's Surface Transportation (FAST) Act dollars.

Bi-State staff encourages other persons receiving a carbon copy of this notice to work with their respective local governments on potential candidate projects. Noted below are details on funding availability, project eligibility and sponsors, costs and match, process, and the deadline.

Funding Availability

Estimated funds to be programmed are based on the remaining balance to the Illinois Quad Cities in STBG monies, estimated target funds, minus all previously programmed funds. Funding levels may be subject to availability through federal appropriations and subject to modifications with the reauthorization of the transportation act, known as Fixing America's Transportation System, FAST, which is authorized through 2021. Beyond FFY 2021, funding levels are assumed at the current levels based on an expectation by the Federal Highway Administration (FHWA) that programming should reflect anticipated projects within a four-year Transportation Improvement Program.

Project Eligibility and Project Sponsor

A candidate project submittal form is enclosed and may be copied for multiple submissions. Eligible projects must be identified in and/or consistent with the Connect 2050: Quad Cities Long Range Transportation Plan. The plan is available online: http://bistateonline.org/transportation/quad-cities-metro-planning/2012-11-13-20-19-45/quad-cities-metro-lrtp-long-range-transportation-plan. Refer to Chapter 3 The System for 2050, Tables 3.3 and 3.4 for a listing of roadway projects. Other eligibility requirements are in the STBG Manual located here: http://bistateonline.org/transportation/quad-cities-metro-planning/2012-11-13-20-10-34/project-programming-processes. This memo supersedes any due dates and funding levels. The manual is for illustration of the

process and criteria. **Transportation projects must be located on the federal functionally classified system (collector or higher functional classification) to be eligible or identified as an exception in the STBG Manual.** Projects must be sponsored by state and local governments or transit systems, as designated by the Illinois DOT.

STBG funds can be used for any mode of surface transportation – roadway, transit, pedestrian, or bicycle facilities.

### **Project Cost Estimates, Matching Funds and Minimum Project Cost**

Project costs should be estimated in Year of Expenditure Dollars (CY2025) and a rate of inflation used by your jurisdiction to estimate Year of Expenditure. Year of Expenditure is expected to coincide with FFY 2024, or 2025. Please note the anticipated program Year in your application that you would like the project to let. A procedural checklist is available in the STBG manual. The manual is posted online at the link noted above.

The STBG funds are required to be matched with at least 20 percent and not more than 50 percent non-federal funds. Projects must have a total project cost no less than \$125,000, as the federal-aid process requires considerable administration on the part of the project sponsor.

### **Process**

The Quad Cities MPO Transportation Technical Committee ranks candidate projects and recommends programming to the Transportation Policy Committee in accordance with the manual noted above. Recommendations and selection of a project(s) will occur at Technical and Policy Committee meetings in September 2021, respectively. Notice of these meetings will each be sent at least one week prior to the meeting date.

### **Deadline**

**Candidate project submittals are requested by Friday, August 20, 2021 at 4:30 p.m. No projects will be accepted after this date.** Project submittals may be mailed to our office (1504 Third Avenue, Third Floor, Rock Island, IL 61201) or e-mailed to [fvasquez@bistateonline.org](mailto:fvasquez@bistateonline.org).
